NYS DREAM Act Supporting Documents

In order to access NYS financial aid funds through the DREAM Act, students of various immigration statuses must fill out at least two short applications. First, they must fill out the NYS DREAM Act application and then the application for the program they would like to access. Currently, students can only apply for TAP, Excelsior, and the Enhanced Tuition Award. Other programs will be available in the Fall.

At the end of each application, students may be asked for supporting documents. These documents must be uploaded right onto the application. Below we list the documents students may be asked to provide.

^{*}These forms will be provided for download, if necessary. After completing the form, the student must upload it into their application.

Best Practices for uploading Supporting Documents:

- Only upload the required supporting documents
- If student is undocumented, redact street address from all documents
- For immigration status, if the student doesn't have the indicated document but has another document that proves their status, upload it. HESC will review the documentation in order to determine if it is valid.
- All support documents must show your name and must be uploaded by the deadline
